  - The line item for insurance expense was increased as approved to allow for higher projected premium costs.
- MOTION (from Committee): To present the Capital Budget to the Convention Body allocating funds for capital needs including new computer hardware, telecommunications needs, website update, etc. Motion passes on vote.
- There is a conflict in the financial policies (specifically section 3.5.1) regarding unauthorized expenses. Explanation given by PNP Karen Stevens that registration fees are allowed to be

- <u>paid</u> for delegates by a chapter, but they should not be paid by individual members and then <u>reimbursed</u> by the chapter.
- MOTION (from Committee): NEB approval is given for presentation of the budget and financial policies at the Convention. Motion passes on vote.
- Discussion ensued regarding changing the process for Convention registration in the future. Our CPA has stated that we should avoiding reimbursements to individual reimbursements. It is acceptable (per previous attorney Don Alexander) for chapters to pay for delegates to attend the Convention as it is an authorized program expense.

## **OH 15**

- OH15 (Lima chapter) would like to re-join BSMA with a new charter and new EIN, but would like to keep the same chapter number. The chapter was disbanded in 2008 due to multiple compliance issues.
- MOTION: OH15 Lima chapter should be allowed to re-join BSMA with its old chapter number and name, but with a new charter and new EIN. Friendly amendment (accepted) to require full oversight by the Dept. of OH for 2 years, with audits to be performed twice a year. Motion is seconded and passes on vote.
